National Single Window NL

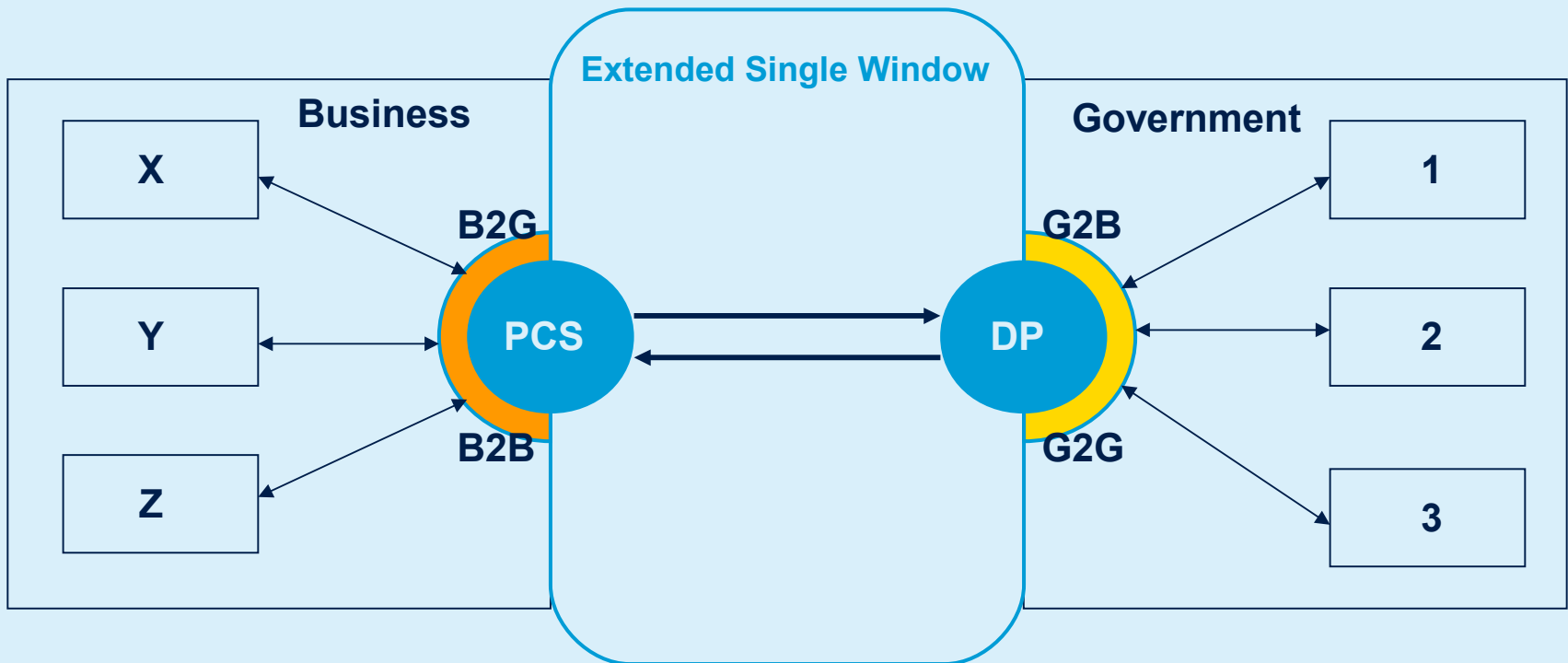
“Single Window” is internationally defined and accepted as:

“**a facility** that allows parties involved in trade and transport to lodge standardized information and documents with a single entry point to fulfil all import, export, and transit-related regulatory requirements. If information is electronic, then individual data elements should only be submitted once”.

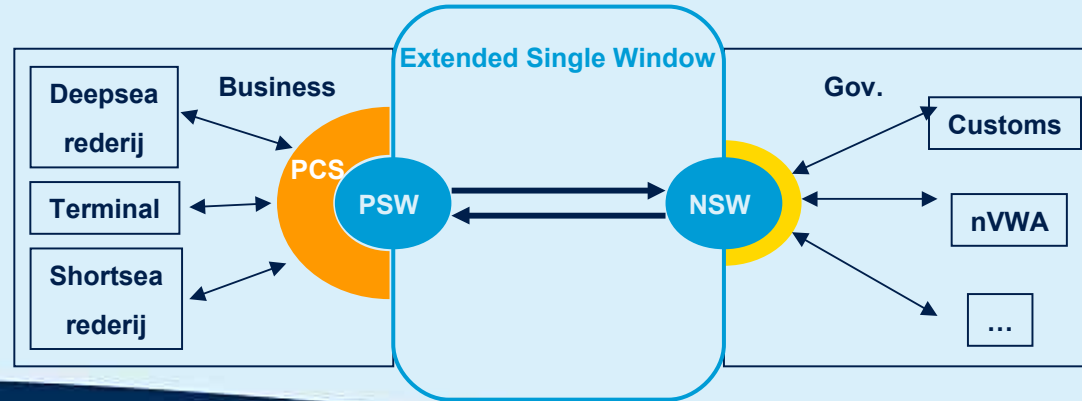
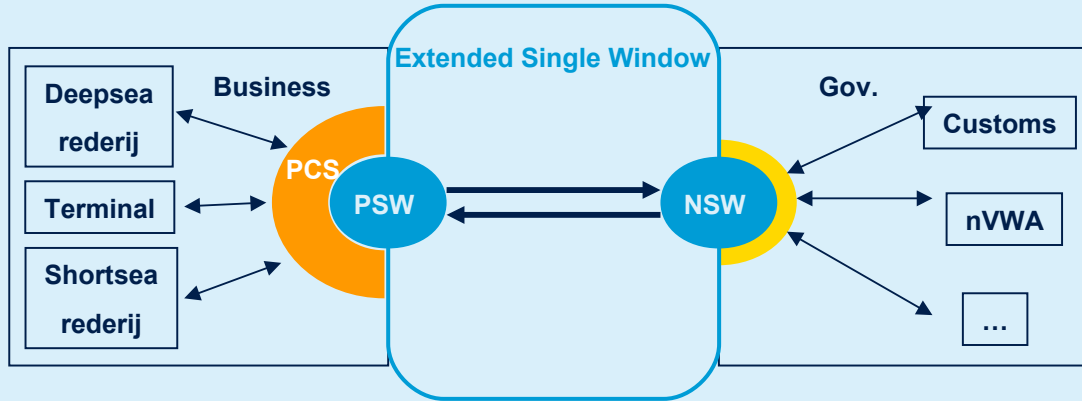
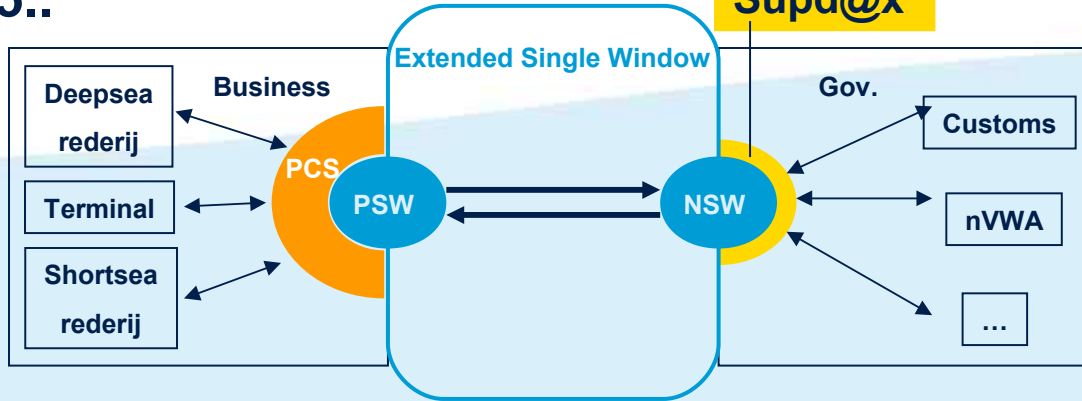
National Single Window NL = NL version of the SW, made intelligent and further dressed to facilitate trade and transport.

- NSW not optional: European regulation to realize a MSW before June 1, 2015, to facilitate electronic reporting of ship related notifications to the public authorities.
- Additional effort by RWS to realize an SW for inland shipping (RIS), to be aligned with the MSW
- National policy:
 - 1 Single Window for Government.
 - Connect with running initiatives.
 - Shared vision by Government and the Business.
 - National Coordination.

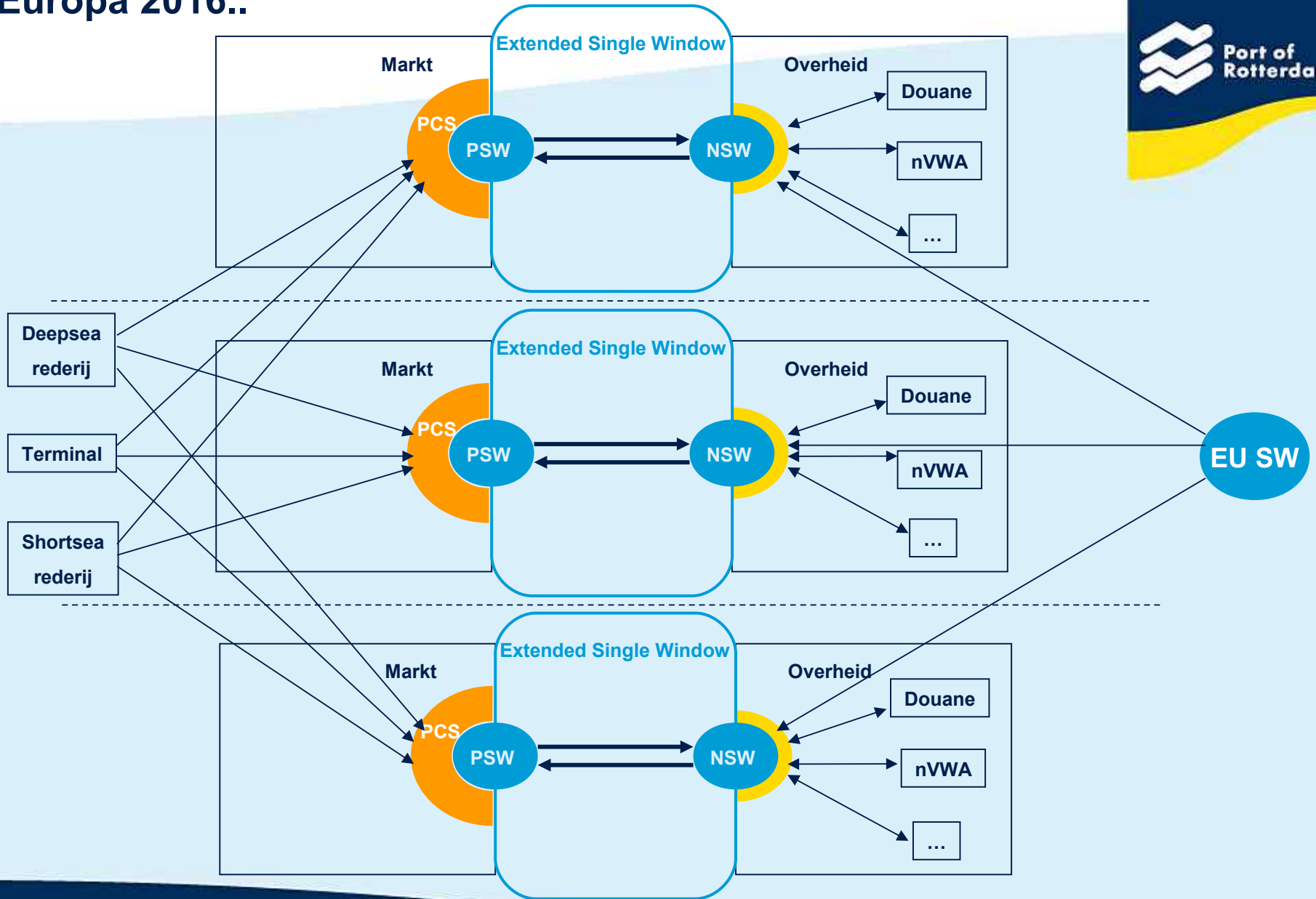
National SW(Government): Digipoort (Logius) Port SW: PCS (Portbase)



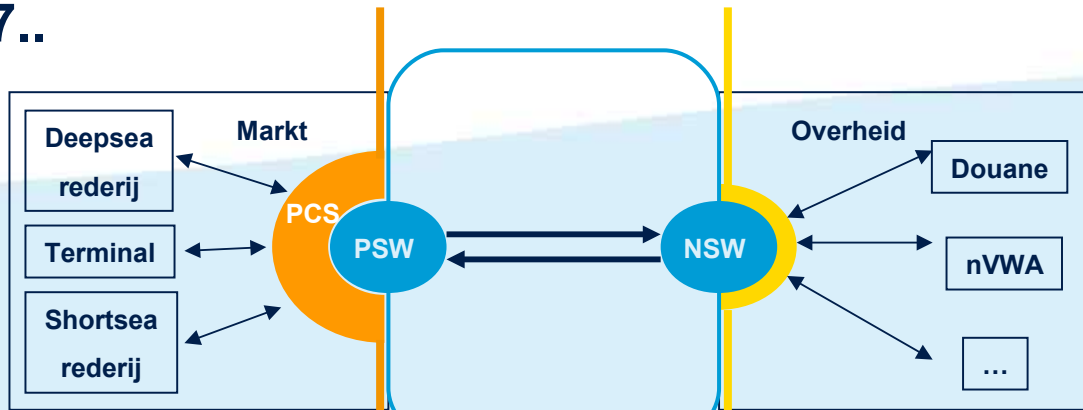
View from the Port of Rotterdam Authority



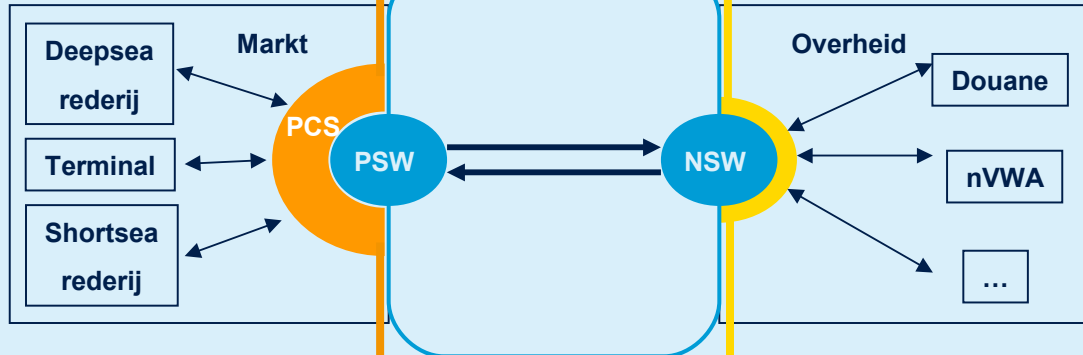

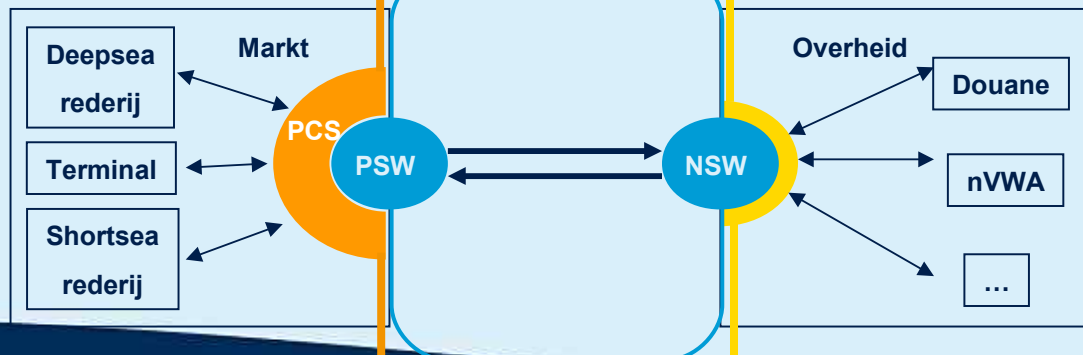

PoR interest in MSW

- NSW is globally in all large seaport;
- European Directive and Dutch legislation
 - Min.I&M is leading;
- For PoR, the relation with Customs is important;
- To secure the investment in Portbase
- To protect the business relation with the main carriers;
- To capture the B2G transactions for potential re-use data in the port community.

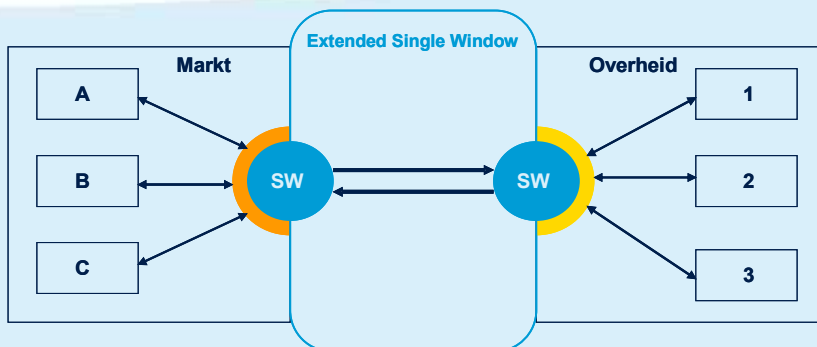
Harbourmaster interest in MSW



In addition to the interest of PoR:

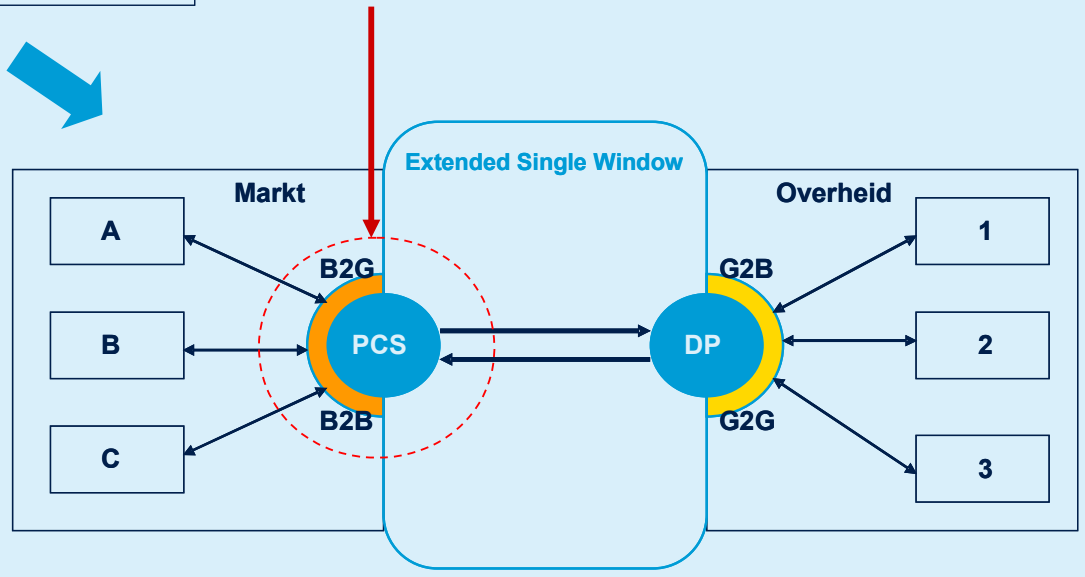
- “Post-box HM” (at this moment on PCS) could be placed within the NSW;
- The information processes of the division HM becomes dependent on the functioning of the MSW;

Interest Portbase in NSW

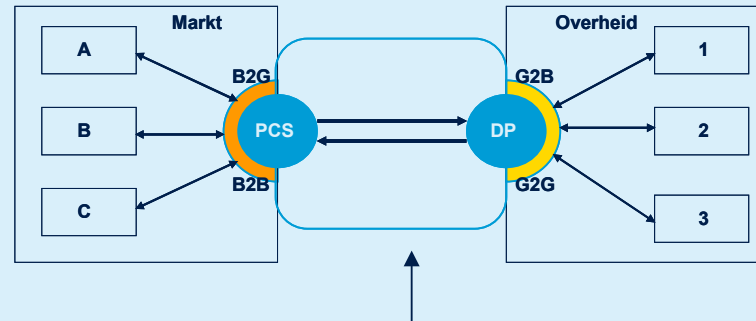


Positioned in SW environment

and Government

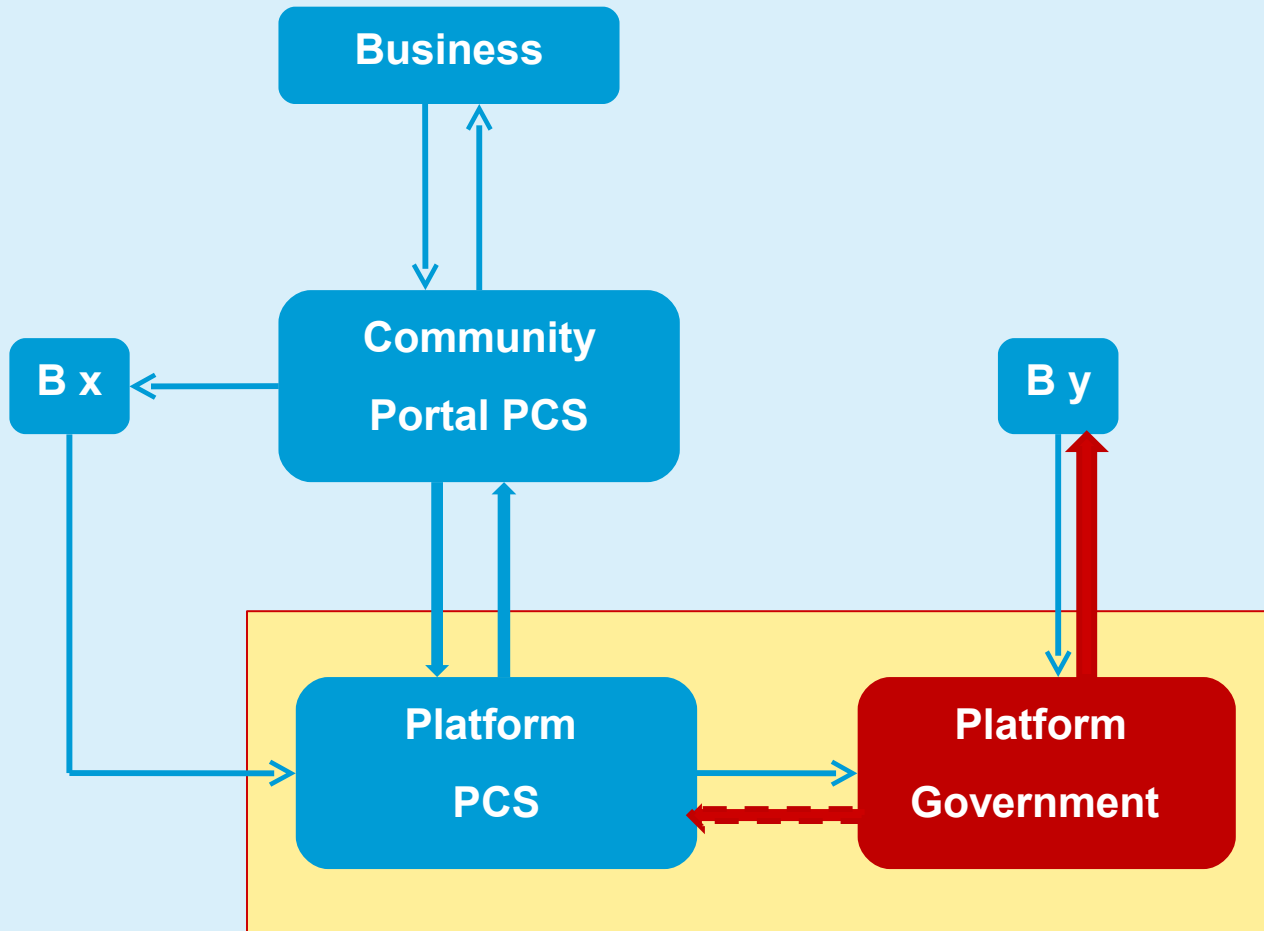


Current Policy PoR



- Since 2004, the strategy of PoR and HM has been to position PCS in the SW environment.
- However, Government does not support an exclusive relation with PCS.
- Lobby of PoR and PoA to make PCS available for establishing a MSW.
- Investment from PoR and PoA to absorb the costs of B2G transactions
- Post-box for mandatory reporting to HM on PCS

Current (preliminary) solution



Status Quo

- Government wish to use PCS, but does not finance the B2G transactions through PCS;
- The Ports of Rotterdam and Amsterdam offered to deal with these costs, under the condition that PCS is included in the MSW
- Not all ports work with PCS at this moment
- Government's opinion is that business should be able to report to Government platform directly, if they wish, costs covered by Government
